The 45th Challenge Match between the Milwaukee County Public Links Association and the Northern Illinois Men's Amateur Golf Association will be held on Saturday, September 18, 2021, at FOX LAKE COUNTRY CLUB. Each Association will field a team made up of approximately 32 players with a wide range of handicaps; that is, neither team will be dominated by either higher or lower handicap players. The competition will be an 9:00 A.M. shotgun start. All contestants must arrive no later than 8:30 A.M. and will share a cart with their opponent.

Once the teams have been selected by each Association, all of the players on the team will be ranked by Course Handicap. If more than one player has the same handicap, the Team Captain will designate which of the players is the higher ranked player. The competition will then be Match play between the No. 1 MCPLA player and the No. 1 NIMAGA player and between the No. 2 MCPLA player and the No. 2 NIMAGA player, etc. The higher handicap player will receive strokes from his opponent equal to the difference between their Course Handicaps. For example, if the No. 1 player for MCPLA has a Course Handicap of 2 and the No. 1 NIMAGA player has a Course Handicap of 3, the NIMAGA player would receive 1 stroke from the MCPLA player.

Each individual match will be worth 3 points: one point for the front 9, one point for the back 9, and one point for the 18. If any of the 3 components of the Match are halved, each player will receive 1/2 point with respect to that component. The winning team will be the team accumulating the most points.

The Competition will be played under USGA "Rules of Golf" governing Match Play.

It is our desire to field the strongest team possible. If you are not selected for the Team, you will be notified and your check will be returned to you.
